



## PACE Student Rules Contract

This contract outlines the specific rules that need to be followed by all participants during the summer program. These rules have been designed to create an optimal learning environment, to promote positive social interactions, and to ensure the safety and well-being of participants. In addition to the stated rules, general guidelines for behavior and disciplinary procedures are shared in the Student Handbook. All of our rules and guidelines are based on the expectation that students will maintain a friendly, cooperative, and responsible attitude toward all persons in the Badger Precollege community and within the campus and communities at large.

*Please review these rules carefully and then sign below indicating your willingness to adhere to the rules and understanding that a serious infraction of the rules may lead to dismissal from the program without refund.*

1. I will be safe, include everyone, respect others, challenge myself and have fun.
2. I understand that Badger Precollege Summer Programs are first and foremost academic programs and I commit myself to serious and honest work for the duration of the program. I will attend all classes and recreational activities.
3. I will stay within the program boundaries at all times with appropriate supervision:
  - i. **PACE Students will be supervised by an adult while on campus and are expected to stay with their assigned group, in accordance with university policy.**
4. I will conduct myself in an appropriate manner and dress appropriately at all times while at meetings, classes, meals, on field trips, or during any other activity.
5. I understand that violation of any city, state, or federal law will not be tolerated. The following are not allowed: gambling; possession of tobacco products, drug paraphernalia, fireworks, weapons, explosives, ammunition; sex; harassment of any kind. I understand that destruction of campus or personal property will not be tolerated, and any damages will be charged to the student/family.
6. I understand that these rules were created to promote an optimal learning environment and ensure safety and the well-being of the group.
7. While cell phones are permitted at PACE, it is expected that students refrain from using their cell phones during class and recreational times. *It is further expected that students refrain for using their cell phone and/or earbuds while walking from place to place on campus for reasons of safety.*

*NOTE: The Program Manager may establish additional rules as behavior warrants. The consequence for breaking rules can include Disciplinary Review Board and/or other consequences up to and including dismissal from the program without refund.*
